JKMSCL proposed that in case of all purchase orders placed between 20-12-2019 and 05-03-2020, FMC clause would be invoked & therefore maximum delivery period would be extended upto 150 days (in case of normal delivery period of 60 days) and 180 days (in case of normal delivery period of 90 days) with a phased delivery of 50% completion by 60/90 days, rest 30% completion by 110/140 days and balance 20% completion by 150/180 days respectively without imposing LD. Any deviation to this stipulated phased delivery period, will attract LD as per the following criteria:

No FMC would be invoked for COVID -19 supplies and in case of all those suppliers who were in default as to the contractual obligations of JKMSCL as on 19-02-2020.
