MINUTES OF MEETING

Subject: Meeting of the Technical Bid Evaluation Committee held on 28.02.2025 for the acceptance of demonstration report for the finalization of Rate Contract for the procurement of "Machinery & Equipment" under NIT/JKMSCL/M&E/2023/605 dated 19.10.2023.

1. e- bid for the finalization of Rate Contract for the procurement of Machinery & Equipments was uploaded vide no NIT No: NIT/JKMSCL/Mach/2023/605 Dated 19.10.2023 and was opened on 11th March 2024 at Corporate Head Office, Jammu and Srinagar at 11.00 A.M. The aforesaid tender was opened in the presence of technical advisory/evaluation committee constituted for the purpose by Board of Directors, JKMSCL during 3rd board meeting for the purpose.
2. With reference to clause 2.1.9 Chapter II of the Standard Procurement Procedure approved during 2nd Board Meeting, it was decided by the Technical Advisory / Evaluation Committee that the Chairman, Technical Advisory / Evaluation Committee shall get the preliminary evaluation done by the sub-committee and then shall get the minor infirmities asked from the respective bidders, if any. After downloading the minor infirmities submitted by the bidders, the same shall be re-evaluated by the Sub Committees followed by technical evaluation by the technical experts and the final report shall be placed before the Technical Advisory Committee for further decision/recommendation.
3. Further, sub committees constituted to assist the Technical Evaluation Committee of JKMSCL completed the compilation and scrutiny / evaluation process and thereafter the observations made by the sub- committee were placed before Technical Advisory Committee constituted for the purpose by Board of Director, JKMSCL for final scrutiny / evaluation of bid documents so as to arrive at qualifying bidders for further evaluation by means of power point presentation /demonstration and catalogue evaluation by the technical experts.
4. As per the decision taken by Technical Evaluation / Advisory Committee, the evaluation by means of Physical Demonstration/Power Point Presentation & Catalogue evaluation was carried by the panel of technical experts to ascertain the quality parameters, specifications and other qualifying parameters as laid down in the NIT.
5. Subsequently representation was received against M/S MBS India which was re-evaluated by the sub committee and it was observed that :

That the firm M/s MBS India was not considered as the company has submitted MD-7 with application for registration dated 13.12.2023 i.e. after the last date of Submitting an online application to CDSCO i.e. 30.09.2023.

Further, the firm has submitted that application for registration was submitted on 05.04.2023 and the same was provided with the minor infirmities, representation and the committee accepted the bid for the item anesthesia work station(basic).

In response to the representation from M/s Cardiolabs healthcare India Pvt Ltd. regarding fee paid at the time of application submission as Rs.01.00 on 13.12.2023 with transaction ID 1312230044045. It is submitted that at the time for applying for registration on 05.04.2023, an amount of null 56000.00 were paid vide transaction ID 0504230014562 and same was considered for recommendation of the bidder for the item after submitting the infirmities for anaesthesia work station as the application was submitted before the last date.

However, one more application dated 04.06.2024 is attached wherein again null 56000.00 were paid on 06.04.2024 vide transaction ID 0604240031929. Further regarding the quality certification, the bidder has submitted ISO- 13485:2016 having validity till 04th October 2026 which was asked in the tender and the item confirm to EN 60601-2-13 requirement for safety and essential performance of anaesthesia system for which bidder has submitted certificate of compliance from Ente Certificazione Machine Srl having notified body number:1282.










6. The Technical experts after demonstration given by M/S S R Technomed submitted that for the equipment Anesthesia Work Station, the Test report of the IEC-60601-2-13 (Requirement for safety and essential performance of anaesthesia system) was not available/verified. BIS/ISO 13485/CDSCO Registration Certificate was not satisfactory.
7. Accordingly, based on technical evaluation of the documents, demonstration & catalogue evaluation strictly as per the specifications laid down in the NIT, the following bidders were found qualified / disqualified by the technical experts of the concerned specialities for opening of financial bid of qualified bidders :

After the opening of financial bid of single bid qualified item, the committee decided that before placing such equipments in the Purchase Committee, JKSMCL, price justification/rate reasonability with other premier institutes be also done so that price justification is ensured.
