- 1. E- bid for the finalization of Rate Contract for the procurement of Machinery & Equipments was uploaded vide No NIT No: NIT/JKMSCL/Mach/2024/611 Dated 04.01.2024 and is opened on 08.06.2024 at Corporate Office, Jammu and Srinagar respectively. - 2. 
