Item No.10.01

Approval of Minutes of 9th Meeting of Board of Directors-JKMSCL:

- b) For the regular purchases during COVID-19 period wherein penalty clause is categorically defined, the applicability of Force Majeure Clause (FMC) be examined on case-to-case basis and extension / non extension may be considered as such."

- In case the supplier executes the supplies above 95%, the proportionate unexecuted supply percentage value of the Performance Security / Security Deposit shall be imposed as fine before release of Performance Security / Security Deposit e.g if a supplier has executed the supply at 95.10%, 4.90% of the Performance Security / Security Deposit shall be imposed as fine and so on."
