

- 2. As per tender notification Pre-Bid meeting was held on scheduled date i.e. 18-11-2024 at 11:00 A.M at Corporate Office Jammu and Srinagar. Owing to the Discussions, a Corrigendum was issued vide No: JKMSCL/Drugs/ Corg/ 637/2024/140901-92 dated: 26-11-2024 whereby few items were amended, deleted and added in the BOQ. On the representation of bidders, scheduled dates were extended and few amendments were made vide corrigendum No: JKMSCL/Drugs/Corg./637/2024/14345-48 Dated: 03-12-2024 followed by another corrigendum issued vide No: JKMSCL/Drugs/Corg./637/2024/15433-35 dated 20-12-2024.
- 3. Accordingly, e-bids were opened on 28-12-2024., in the presence of Technical Evaluation Committee constituted by Boards of Directors during ^{1st} Board Meeting and amended by Boards of Directors during ^{3rd} Board Meeting, JKMSCL for the purpose, and as per the system generated report, bids received are attached as Annexure "A".


