MINUTES OF MEETING <u>CONSIDERATION OF TECHNICAL BIDs</u> <u>9-12-2024, 11:00 A.M</u>

- Sub: Finalization of tenders invited for procurement of "Allopathic Drugs" Uploaded vide No:JKMSCL/Drugs & Medicines/2023-2024/631 Dated: 05-02-2023.
 - 1. e- Bid for the finalization of Rate Contract for the procurement of **"Allopathic Drugs"** Uploaded vide No:JKMSCL/Drugs & Medicines/2023-2024/631 Dated: 18-07-2024.
 - 2. As per tender notification Pre-Bid meeting was held on scheduled date i.e. 02-08-2024 at 11:00 A.M at Corporate Office Jammu and Srinagar. A Corrigendum was issued vide No: JKMSCL/Drugs/Corg/631/2024/7670-73 Dated: 14-08-2024 wherein Following items were amended and following items are added in the NIT.Another corrigendum was issued vide No: JKMSCL/Drugs/ Corg./ 631/ 2024/7759-62 Dated: 17-08-2024where in one item are amended in the NIT and again corrigendum was issued vide No: JKMSCL/Drugs/Corg./631/2024/8967-69 Dated: 06-09-2024 followed by corrigendum issued vide No: JKMSCL/DRUGS/ Corg/631/2024/7670-73 Dated: 14-08-2024 where in one item are amended in the NIT.

Scheduled date for receipt and opening of Technical Bids were extended upto 31-08-2024 and 02-09-2024, 10-09-2024 and 12-09-2024 respectively.

- 3. Accordingly, e-bids were opened on12-09-2024 at 11.00 a.m., in the presence of Technical Evaluation Committee constituted by Boards of Directors during ^{1st} Board Meeting and amended by Boards of Directors during ^{3rd} Board Meeting, JKMSCL for the purpose, and as per the system generated report, bids received are attached as Annexure "A".
- 4. After opening of e-bids, compilation, preliminary scrutiny and evaluation of bid documents was carried out by the Technical Evaluation Sub Committees constituted for the purpose.
- 5. After evaluation of technical bids, Technical Evaluation Sub Committee reported some documents deficit from the bidders which were notified to the bidders vide notice No. JKMSCL/GM(P&S)/2024/13693-97 dated 18-11-2024with directions to submit the asked documents latest by 27-11-2024.
- One of the bidders namely M/s Bhardwaj Agencies Jammu vide their letter dated 27-11-2024 represented against their rejection for both manufacturers for not meeting Annual Turn Over clause of NIT.

- 7. The representation was considered and the committee found the claims in respect of M/s Systole Remedies Private Ltd. as devoid of merits. However, Turnover of M/s Radix Hi Care Products was found meeting the criteria of 1.00 crores, as the bidder has quoted Disinfectants for this manufacturer and hence was recommended.
- 8. Documents thus submitted by the bidders were again evaluated and a final report was submitted, which is attached herewith as Annexure "A. As per report of Subcommittee, following bidders products offered by the bidders were not recommended, for the reasons mentioned against each:-
