The candidates having more than 05 years of experience in extending consultancy services to the Central / State Government Department & Public Sector Undertakings in public procurement, adequate Experience in successfully completing consultancy service in large scale development Projects/programmes run by the Govt. consultancy experience with programmes/projects supported by the world Bank. UNDP, DFID or other International Reputed Donors in the aforementioned field shall be an added qualification.

The following terms and conditions as per approved hereinafter referred to as policy shall be followed for engagement of Retainer Consultant.

#### 1. The terms and conditions are as under:-

- i) Total 01 number of Retainer Consultant shall be engaged by JKMSCL.
- ii) The Consultant shall be required to provide services at the Corporate Office situated at Jammu/Srinagar.
- iii) Candidates should not be more than 65 years of age on the date of issuance of notification.
- iv) The tenure of engagement of Retainer Consultant (RC), shall depend upon the nature of the assignment. The engagement period of the Retainer Consultant (RC) shall not exceed 120

days in a year and the agreement of engagement shall initially be for a period of one year only and extension of *term of contract* shall be based on performance review as per described policy.

- v) The remuneration for the Retainer Consultant is Rs. 10,000 per day subject to maximum of Rs 01 lakh for a month for a period of 10 days per month i.e 120 days per year (including taxes). Incidental expenses and travel expenses shall be given as applicable to Class-1 officers as per the laid down provisions of J&K TA Rules 2014 as amended from time to time.
- vi) The agreement can be terminated by either JKMSCL or the Retainer Consultant with a prior notice of 30 days in advance.

#### 2. <u>Selection Criteria:-</u>

- i) The selection criteria for a Retainer Consultant (RC), shall be primarily based on the following parameters to be awarded out of total score of 80 by the short listing Committee (as per policy) constituted for the purpose:
- ii) <u>Basic qualification</u>: PG degree from recognized national university duly Governed by University Grants Commission norms and / or International reputed Institute of academic excellence with good academic record—maximum score 40.
- **Experience:** More than 05 iii) vears experience in extending consultancy services to the Central / State Government Department & Public Sector Undertakings procurement. Adequate public in Experience in successfully completing consultancy service scale development in large Projects/programmes run by the Govt. consultancy experience with programmes/projects supported by the world Bank. UNDP, DFID or other International Reputed Donors shall be in added advantage. Maximum score 20.

- iv) **Multi State Experience:** Applicant shall be awarded additional marks in case of Multi State Experience of at least 03 years. Maximum Score 05.
- v) **Jammu and Kashmir State Experience**: The applicant shall be awarded additional marks in case of adequate experience with J&K State Government Department/PSU of least 01 year—Maximum Score 05.
- vi) **Specialized Experience**: Prescribed consultancy experience in procurement of Health and Medical Equipment of at least 02 years—Maximum Score 10.
- vii) Total weight-age assigned to the short listing criteria would be 80.
- viii) The candidates shortlisted by the Short-listing committee shall be interviewed by the Selection Committee constituted for the purpose. A total weight-age of 20 points shall be assigned to interview.

#### 3. Role and Responsibilities:-

- i) The Retainer Consultant shall aid and advise JKMSCL in the preparation of NIT/SBD of all categories of procurement i.e drugs / instruments / disposables / dressing / suture/furniture and Machinery equipments.
- ii) RC shall be providing high level of expertise and experience of procurement of drugs and machinery equipments and also streamlining the annual procurement plan of JKMSCL including demand forecasting and further improvement and maintenance of supply chain management of drugs and machinery equipments.
- iii) To ensure strict adherence to the timelines of finalization of various tenders by introducing a standardized proforma of checks and balances eliminating un-warranted red-tapism and encouraging fair competition and quality procurement at competitive rates.
