On behalf of Jammu & Kashmir Medical Supplies Corporation Limited sealed Expression of Interest (EOI) is invited for empanelment of various firms/dealers engaged in the business of supply/replacement of genuine tonners/cartridges, drum etc of printers, fax, photocopier etc, as an authorised dealer(s) of the original manufacturer(s)/direct importer(s) within the state of Jammu & Kashmir within ten (10) days from the date of publication as given below:

3. TERMS AND CONDITIONS:

The interested firms/ bidders shall ensure that:


- i. Items shall have to be provided/installed FOR mentioned in the supply order(s).
- ii. Items should be transported in a manner, to be free of contamination/ deterioration.
- iii. The firm shall be responsible to provide feedback/ status of items till it is received by the respective point of delivery.
- iv. The items shall have to be delivered within a period of 03 working days.
- v. The firm shall be responsible to ensure that the packing shall not be broken/ tampered.
- vi. The Empanelment shall be for a period of twelve (12) months from the date of signing of Agreement which shall be extendable for another three (03) months with mutual consent of both the parties.
- vii. JKMSCL shall have right to get consent from L2, L3 & L4 bidder(s) to match their rates with L1 rates as "Matched L1 Rates". However, preference shall be given to L1 bidder and in sequence of bidding rates as L2, L3 and then L4.

4. Earnest Money deposit and Performance Security:

- i. Firm/ bidder shall need to deposit EMD to the tune of Rs. 5000/- (Five thousand only) in the form of FDR/DD drawn on any of the scheduled/ nationalized bank in favour of Chief Accounts Officer, JKMSCL payable at Jammu; along with the EOI, which shall be converted into performances security for successful/ Empanelled agencies/ firms.
- ii. The performance security shall be released three (03) months after the successful completion of the contract/ last order whichever is later.

5. Termination of Contract:

In case any of the firm/ bidder, empanelled with JKMSCL wish to withdraw before the completion of the contract period, he/she can do so with



minimum one month prior notice to JKMSCL, however, JKMSCL shall have full right to disengage or dis-empanel any of the agencies/ firm in case of any default, without any notice.

6. Penalty Clause:


- i. In case of any default on account of delay in delivery, beyond the specified time, the performance security shall be forfeited and the said firm shall be black listed for a period not less than three years.
- ii. In case of any negligence, with regard to maintain of temperature & other conditions as per labelled conditions/ directions issued by the Corporation in case to case basis, so as to maintain the quality of product from the point of supply to the point of delivery, penalty, which may be forfeiting of Performance Security, blacklisting for a period not less than three years besides other action as admissible under rules in vogue in the state of J&K/ Union of India, shall be imposed.

7. Agreement

The empanelled firm shall have to be entered into an agreement with JKMSCL within ten (10) days from the date of issuance of LOI, with the submission of Performance Security as per clause "4" above.

8. Disputes:

- i. Decision of Managing Director, JKMSCL shall be final and binding.
- ii. Dispute, if any, shall be within the jurisdiction of Hon'ble High Court at Jammu City/ Srinagar City.
