**Subject:-** Hiring of Courier Services from various pickup points to various destinations within/ outside the state.

**EXPRESSION OF INTEREST**

On behalf of Jammu & Kashmir Medical Supplies Corporation Limited sealed Expression of Interest (EOI) is invited from the various courier services working within the state of Jammu & Kashmir within ten (10) days from the date of its publication so as to collect/ deliver the samples of various items to the destinations viz a viz JKMSCL empanelled laboratories as given below:

**2. Service to be provided:**

- i. Corporate Head Office, Jammu to various empanelled Labs as at òlò.
- ii. Corporate Office, Srinagar to Corporate Head Office, Jammu and vice versa.
- iii. Corporate Office, Srinagar to various Empanelled Labs.
- iv. Regional Drug Warehouses Kathua, Rajouri, Doda to Corporate Head office, Jammu.

- v. Regional Drug Warehouses Anantnag, Baramulla, and Leh to Corporate Office, Srinagar (Kashmir).
- vi. Corporate office, Jammu to Drug Warehouses Srinagar, Kathua, Rajouri, Doda, Anantnag, Baramulla.

### **3. TERMS AND CONDITIONS:**

The interested firms/ bidders shall ensure that:

- i. Drug Samples shall be store and transported as per the instructions given on label or by the Corporation with regard to maintenance of temperature, light, moisture and ventilation for each drug from packing point to their destination.
- ii. Drug samples should be transported in a manner, to be free of contamination deterioration and adulteration.
- iii. The firm shall be responsible to provide feedback/ status of samples till it is received by the respective laboratories/ point of delivery.
- iv. The sample shall have to be delivered within a period of :
  - a. Perishable products- within 24 hours.
  - b. Non Perishable products- within 48 hours.
- v. The firm shall be responsible to ensure that the packing shall further be not broken/ tampered.
- vi. The Empanelment of courier service shall be for a period of twelve (12) months from the date of signing of Agreement which shall be extendable for another six (06) months with mutual consent of both the parties.
- vii. JKMSCL shall have right to get consent from L2, L3 & L4 bidder to match their rates with L1 rates as "Matched L1 Rates". However, preference of shall be given to L1 bidder and in sequence of bidding rates as L2, L3 and then L4.

### **4. Earnest Money deposit and Performance Security:**

- i. Firm/ bidder shall need to deposit EMD to the tune of Rs. 5000/- (Five thousand only ) in the form of DD drawn on any of the scheduled/ nationalized bank in favour of JKMSCL payable at Jammu; along with the EOI, which shall be converted who performances security for successful/ Empanelled agencies/ firms.
- ii. The performance security shall be released one (01) months after the successful completion of the contract/ last order which ever is later.

**5. Termination of Contract:**

- i. In case any of the firm/ bidder, empanelled with JKMSCL wish to withdraw before the completion of the contract period, he/she can do so with minimum one month prior notice to JKMSCL, however, JKMSCL shall have full right to disengage or dis-empanel any of the agencies/ firm in case of any default, without any notice.

**6. Penalty Clause:**

- i. In case of any default on account of delay in delivery, beyond the specified time, the performance security shall be forfeited and the said firm/ courier service shall be black listed for a period not less than three days.
- ii. In case of any negligency, with regard to maintain of temperature as per labelled conditions/ directions issued by the Corporation in case to case basis, so as to maintain the quality of medicine/ serum/ vaccine and other perishable products, from the point of collection to the point of delivery, penalty, which may be forfeiting of Performance Security, blacklisting for a period not less than three years besides other action as admissible under rules in vogue in the state of J&K/ Unio of India, shall be imposed.

**7. Agreement:-** The empanelled firm shall have to be entered into agreement with JKMSCL within ten (10) days from the date of issuance of LOI, with the submission of Performance Security as per clause 5 above.

**8. Disputes:**

- i. Decision of Managing Director, JKMSCL shall be final and binding on both the parties.
- ii. Dispute, if any, shall be within the jurisdiction of Honøble High Court at Jammu City/ Srinagar City.
