MINUTES OF MEETING CONSIDERATION OF TECHNICAL BIDS 08-04-2025, 03:00 P.M

Sub: Finalization of tenders invited for procurement of "Surgical Disposable Items"
Uploaded vide No.: JKMSCL/MED /2023/602 Dated: 04-09-2023

1. e- Bid for the finalization of Rate Contract for the procurement of "**Surgical Disposable Item**" was uploaded vide No: **JKMSCL/MED /2023/602** Dated: 04-09-2023
2. As per tender notification Pre-Bid meeting was held on scheduled date i.e. 15-09-2023 at Corporate Office Jammu. A corrigendum was issued regarding technical specification vide No. JKMSCL/GM(P&S)/2023/602/13462-65 dated 02-11-2023 and critical dates for receipt and opening of technical bids were also extended upto 14-11-2023. On the request of intending bidders scheduled dates for receipt and opening of technical bids were again extended upto 21-11-2023 Vide No: JKMSCL/GM (P&S)/2023/602/475-79 dated 14-11-2023 and again upto 01-12-2023 vide No: JKMSCL/GM (P&S)/2023/602/14434-37 dated 21-11-2023.
3. Accordingly, e-bids were opened on 02-12-2023 at 11.00 a.m. at Corporate Head Office, JKMSCL at Srinagar in the presence of Technical Evaluation Committee constituted by Boards of Directors during 1st Board Meeting and amended by Boards of Directors during 3rd Board Meeting, JKMSCL for the purpose, and as per the system generated report, bids received are as under:

4. After the opening of e-bids, compilation, preliminary scrutiny and evaluation of bid documents was carried out by the Technical Evaluation Sub Committee constituted for the purpose.
5. Technical Documents thus found deficit by the committee were notified to the participating bidders vide Notice No: JKMSCL/ GM(P&S)/2024/491-94 dated 19-04-2024, with directions to submit documents pointed deficit by the sub-committee, latest by 29-04-2024, followed by extension for submission of documents upto 04-05-2024 issued vide No: JKMSCL/ GM(P&S)/2024/925-29 dated 29-04-2024. Notice was uploaded on website of JKMSCL as well as individual mails were also sent to the participating bidders.
6. Documents thus submitted by the bidders were again evaluated by the subcommittee and final report was submitted, which is attached herewith as **Annexure "A"**
7. It was observed by the Technical Evaluation /Advisory Committee in its meeting held on 25-07-2024 that most of the bidders have not been recommended by the Sub-

- committee for want of Market Standing Certificate, issued by the licensing Authority. Drug Control Officer, present in the meeting informed that the, mentioned items fall under **Medical Devices** and in order to regulate all the Medical Devices, MoHFW has Published GSR 102(E) dated 11-02-2020 for regulation of Medical Devices in Phased Manner. As per the said notification Class A & B medical Devices are under license Regime from 01-10-2022 and class C & D from 01-10-2023. After threadbare discussions, it was decided unanimously to give another chance to bidders to prove that the product offered in the bid are being manufactured and sold by them for the last three years supported with the Purchase Orders and Market Standing Certificate issued by the Licensing Authority after 01-10-2022 for class A&B Medical Devices and 01-10-2023 from class C&D. In the interest of healthy Competition, the bidders be directed to submit the deficit documents pointed out by the subcommittee within 7 days positively without any further correspondence.
8. It was also decided by the Technical Evaluation/Advisory Committee to call the samples from the bidders, for the items, recommended by sub-committee, after further evaluation of Technical documents.
 9. Accordingly, as per decision taken in the Technical Evaluation/Advisory Committee held on 25-07-2024, Bidders who have submitted asked documents against Notice No: JKMSCL/ GM(P&S)/2024/491-94 dated 19-04-2024 were again informed to submit their deficient documents latest by 08-08-2024 vide Notice No: JKMSCL/ GM(P&S)/2024/6845-49 dated 01-08-2024. Notice was uploaded on website of JKMSCL as well as individual mails were also sent to the participating bidders.
 10. Documents thus submitted by the Bidders were again evaluated and III report was submitted by the sub-Committee on 31-08-2024. As per decision taken in the Technical Evaluation/Advisory Committee meeting held on 25-07-2024, bidders declared qualified by the sub-committee were asked vide letters dated 17-10-2024 to submit samples of their qualified items with the Sample Ware House Amphalla Jammu latest by 28-10-2024. At this stage, various bidders represented for not calling samples from them for various manufacturers, claiming to have submitted asked documents.
 11. All the representations were again sent to Sub-committee for examining. Sub-committee after considering the representations, declared few bidders qualified for further consideration and rest of the representations were declared devoid of merits, Enclosed as **Annexure "B"**.
 12. It was also informed to the Technical Evaluation/Advisory Committee that a committee for verification, coding and decoding of samples has been constituted vide No: JKMSCL/602/2024/9651-56 dated 30-12-2024.
 13. Technical Evaluation/Advisory Committee in its meeting held on 01-01-2025, took note of all the process and it was decided to call the samples of the qualified items from the bidders, now recommended by the sub-committee after considering the representations.




14. Samples thus received at Sample Ware House, were verified and coded by the committee constituted for the purpose.
15. Principal, GMC Jammu, GMC Srinagar and Director Health Services Jammu and DHS Srinagar were requested vide this office letter No: JKMSCL/602/2025/85-93 Dated 16-01-2025 to depute technical experts from Anaesthesia, Surgery, Orthopaedics and Gynaecology Department for evaluation of Samples. Coded samples were placed before the Technical Experts for their consideration and evaluation. Technical experts after physical evaluation of samples submitted a detailed report of Approved/Not approved samples. Report thus submitted was decoded and a detailed report based on evaluation of samples was prepared which is attached herewith as "Annexure-C".
16. Technical Evaluation/Advisory Committee after perusing the detailed Report of Sample Evaluation accepted the same and recommended to open the Financial Bids of the items declared Approved by the Technical Experts (Annexure C) from various specialities, provided the bidders consent for bid validity extension.
