Minutes of the Meeting

Subject: A meeting was held on 12-03-2022 at 02:00 Pm under the chairmanship of Managing Director, JKMSCL in his office chamber to discuss and resolve issues/ queries /Clarification sought by firms/ prospective bidders/ suppliers of JKMSCL.

The point's discussed during the meeting are as under:-

- 1 MD, JKMSCL re-assured the bidders/ suppliers that the matter of release of pending EMD's is being done on priority. Inter-section work


of verification on EMD's is going on and will be shifted to accounts section for the final release of payments soon.

- 2 It was requested by the MD, JKMSCL to the bidders/ suppliers to furnish a consolidated list of all the pending EMD's. Also reiterated to enlist the names who requested for release of payment against Liquidated Damages and Penalties.
- 3 It was represented by Mr. S.K. Khanna that he paid LD Charges to the tune of 20% whereas, the maximum amount of LD charges is 10% Mr. S.K. Khanna was asked to raise this matter with FA/CAO and furnish a documentary evidence to resolve the issue.
- 4 It was re-emphasized by the MD, JKMSCL that the FA/CAO has to bring it to the notice of the GM (Adm.) if the bills are delayed from the Drug Warehouses. As the GM (Adm.) has already been directed to sought an explanation from the Medical Officers of Drug Ware Houses if the bill are delayed by them.
- 5 MD, JKMSCL reiterated to ensure supply of standard drugs. He requested supplier/ bidders not to work with the manufacturers who provide sub-standard drugs or who have been debarred or blacklisted by any state govt. etc or other.
- 6 All the bidders/ suppliers requested to revoke the 0.25% per day penalty in order to make working of bidders/ suppliers smooth and hassle free by reducing the financial burden of penalty on them. It was asked by the MD, JKMSCL to put up the representation with documentary support for further discussion.
- 7 It was requested to extend the delivery period of equipment from 90 days to 120 days. It was requested to justify the extension in delivery period with documentary evidence, if in case any other corporation is asking/ allowing the delivery period for equipment as 120 days.
- 8 A bidder apprised that equipments were supplied in 500 bedded Paediatric Hospital around eight months back. The installation report of equipment is still pending with department. He was asked to provide a written representations, so that the matter could be taken up with the concerned authorities.
- 9 The issue of FMC clause, for 2nd and 3rd wave of COVID-19 was again raised by the bidder wherein, all were requested to provide documentary proof by GOI giving benefit under FMC clause for 2nd & 3rd Wave of COVID-19.
- 10 All were requested to raise the issue of any wrongful deduction of money, to the FA/CAO with documentary proof along with a written representation.

- 11 It was re-emphasized by the MD, JKMSCL and directed to the FA/CAO that if the supplier fulfil all the requirements under SPP, their payment should not be delayed and released immediately after the availability of funds.
- 12 Query has been raised by various bidders with regard to the Non Conviction Certificate issued by Drug Control department of various states for one year validity. MD, JKMSCL accepted the query and necessary amendment shall be taken.
- 13 Efforts of MD, JMSCL were appreciated by all the bidders/suppliers for taking up their issues seriously and all the team efforts to resolve them.
