Minutes of the meeting of Financial Committee held on 14th September, 2018 for finalization of Annual Rate Contract of the group "Dental Machinery Equipments"....regarding.

- 1. E- bid for the finalization of Rate Contract for the procurement of "Dental Machinery and Equipment's, was uploaded vide NIT No:NIT/JKMSCL/DEN/2018-19/292, Dated 23-04-2018and Corrigendum was issued vide No. JKMSCL/ PS/ MD/ Corg/ 2018/613-15 Dated 15.05.2018 and Extension for opening of technical bid was issued vide No. JKMSCL/Corg/20185/1078-81 Dated 23.05.2018 was opened on 30th May 2018, 11.00 A.M at Corporate Office, Srinagar.
- 2. Accordingly, e-bid was opened on 30.05.2018 at 11.00 am at Corporate office, Srinagar in the presence of Technical Advisory/Evaluation Committee constituted by Board of Directors during 1st Board Meeting and amended by Board of Directors during 3rd Board Meeting, JKMSCL for the purpose and as per the system generated report, the following bidders were found to have been participated in respective Tender.

In Tender Dental Machinery & Equipments, 03 bidders were found to have participated.

- 3. Therefore, after the opening of e-bid, Technical Advisory/Evaluation Committee decided that the compilation, preliminary scrutiny and evaluation of bid documents shall be carried out by the Technical Evaluation Sub Committees constituted for the purpose. The report of technical Evaluation Sub-Committee shall be placed before Technical Evaluation Committee for further necessary action.
- 4. Accordingly, the sub-committee constituted vide order no. JKMSCL/PS/GM/K/2018/1451-55 Dated 22.06.2018, has preliminary evaluated the Technical bid documents of below mentioned Firms/Bidders and submitted its report:-

5. The shortcomings that came under Minor Infirmities were asked from the respective firms as per Clause 2.1.9 of Chapter II of Standard Procurement procedure approved by the Board of Directors during 1st Board meeting and the technical bid documents were again evaluated by the sub-committee and the report was submitted to the technical Evaluation Committee for perusal and further necessary action.

- Further it was decided that the concerned firms shall be informed accordingly for Demonstration of Samples/Catalogues at Government Dental College, Srinagar.
- Accordingly, the eligible bidders were asked to submit the samples and Catalogues of Dental Machinery Equipments wherein letters were issued time to time with the directions that if the samples were not received within stipulated time, claims of the firms shall not be entertained.
- 10. The samples/Catalogues of Dental Machinery Equipments items were submitted by the eligible bidders which were placed before Technical Experts deputed by the Principals of Government Dental College, Jammu/Srinagar and Directorate of Health Services, Kashmir and the said experts were assisted by the committee constituted by the this office for the purpose.
- 11. The Technical experts after the demonstration of Sample/Catalogues of Dental Machinery Equipments submitted by the eligible participating firms submitted the report. According to the report, only one bidder i.e. M/s Confident Dental Equipments Ltd. has qualified for Eight (08) items only minutes placed C/F side of the file.
- 12. Now, in order to proceed further in the matter, the financial bid of the participating bidder who was found qualified by the Technical Evaluation/Advisory Committee is required to be opened. Accordingly, the meeting of Financial Evaluation Committee was fixed on 14th September 2018 at 11.AM at JKMSCL Corporate Office, Srinagar.
- 13. The financial bid was opened in presence of the members of the Financial Evaluation Committee & after examining/ scrutiny of system generated BOQ downloaded from the e.portal, the committee has decided to ascertain the reasonability of rates from Rate Reasonability Committee as per Board decision for consideration and appropriate decision in the matter thereafter.
