**Subject: Blacklisting / Debarring order in favour of M/s Pyramid Healthcare, Ahmedabad, Gujarat.**

**ORDER NO: 79 -JKMSCL of 2025**

**DATED: 20 /09/2025**

Whereas, the NIT for finalization of Rate Contract for the procurement of Machinery & Equipment was issued vide No. NIT/JKMSCL/M&E/2023/ 609 dated 14-12-2023, wherein the item CO2 Fraction Laser was tendered;

Whereas, the technical bid was opened on 04-04-2024 and as per the bid document, it was found that M/s Pyramid Healthcare is acting as Importer, M/s Bluecore, Korea as Manufacturer and M/s Atomed Healthcare Systems Pvt. Ltd., New Delhi participated as bidder for the item CO2 Fraction Laser on the basis of authorization issued by M/s Pyramid Healthcare in their favour dated 14-03-2024;

Whereas, the financial bid of the said tendered item was opened on 17-05-2025 and subsequent to the opening of the financial bid, it came to notice that M/s Atomed Healthcare Systems Pvt. Ltd. have uploaded manipulated and forged documents in support of the client base;

Whereas, the documents were perused and following came to the fore:

- i) The first purchase order copy uploaded by the bidder, purportedly issued by M/s Haffkine Biopharmaceuticals Corporation Ltd. under Order No. 950A/ Haffkine/Procurement Ce11/E-67O/ 128 Slice CT' Scan Machine/2018- 19 dated 07.02.2019, claims to be for the item CO2 Fractional Laser, Model Zenpro issued to M/s Pyramid Healthcare. However, upon verification, the original purchase order pertains to 128 Slice CT Scan Machine, issued in favour of M/s Siemens Healthcare Pvt. Ltd.
- ii) The second order copy, uploaded under GEM Contract No. GEMC-51L6877O2558260, allegedly for CO2 Fractional Laser, Model Zenpro, in the name of M/s Pyramid Healthcare, was verified from the GeM portal. The original order under the same contract number pertains to the item Somatom Confidence, brand Siemens Healthineers, awarded to M/s Siemens Healthcare Pvt. Ltd.

Whereas, the discrepancies have been verified through the respective portals and it got confirmed that the uploaded documents do not match the original records. Hence,



the order copies submitted in the bid document appear to be manipulated and/or forged.

Whereas, a notice was issued against the bidder by JKMSCL vide No. JKMSCL/GM/Adm/2025-26/2348-49 dated 10-06-2025, wherein the bidder was given an opportunity to submit the written clarification and in response the bidder submitted its reply on 13-06-2025, attributing the error to documents provided by Importer i.e. M/s Pyramid Healthcare.

Whereas, the bidder also communicated that the matter was forwarded by them to Importer firm and upon receiving the same shall be submitted to JKMSCL;

Whereas, in the meantime, this office had also received a letter issued by M/s Pyramid Healthcare addressed to M/s Atomed Medical Systems Pvt. Ltd., wherein M/s Pyramid Healthcare have admitted that the wrong documents were forwarded to the bidder due to internal miscommunication and termed it an "unintentional mistake";

Whereas, M/s Pyramid Healthcare had also submitted an affidavit on non-judicial stamp paper duly notarized and undertakes as under:

*"the contents of bidding documents, its bidding forms Annexure I to Annexure VIII and other information submitted for bid no. (NIT/JKMSCL/ME/2023/609 are true and correct to the best of my knowledge and nothing has been concealed therein"*

*"In case any variation/ discrepancy/wrong declaration found during scrutiny at later stages, I/We shall be held personally responsible & JKMSCL may take any action against including blacklisting /debaring of my/our firm for a period not less than 05 years."*

Whereas, the matter was placed before the Disciplinary Committee in its meeting held on 01-08-2025 and it was decided by the committee that keeping in view the principle of natural justice, a show cause notice be served upon the M/s Pyramid Healthcare to explain the position within 07 days as to why JKMSCL shall not initiate action under rules as prescribed in NIT / SPP of JKMSCL.

Whereas, a Show Cause Notice was issued against M/s Pyramid Healthcare vide No. JKMSCL/GM/DISC/2025-26/4852-59 dated 21-08-2025 for seeking explanation on the above mentioned facts but despite of lapse of considerable time the importer did not submitted the reply.

Whereas, the matter was again placed before the Disciplinary Committee in its meeting held on 11-09-2025 and the committee took note of the non-responsive attitude of M/s Pyramid Healthcare in not responding to the Show Cause Notice, which depicts that the importer has nothing to say in its defense;



Whereas, the Committee also found that M/s Pyramid Healthcare had furnished false declaration / undertaking / information / forged documents and keeping in view the Terms & Conditions of the NIT/SPP, it has been decided by the Committee to blacklist the importer viz. M/s Pyramid Healthcare for a period of two (02) Years;

Therefore, in view of above mentioned facts, M/s Pyramid Healthcare, Ahemdabad, Gujarat is hereby blacklisted for a period of 02 Years from the date of issuance of this order.
