**Subject: Blacklisting / Debarring order in favour of M/s Dynaclean Industries, Coimbatore, Tamil Nadu.**

**ORDER NO: 80 -JKMSCL of 2025**

**DATED: 20 /09/2025**

Whereas, e-bid for finalization of Rate Contract for the procurement of Machinery & Equipments was issued vide No. NIT/JKMSCL/M&E/2023/647 dated 27-12-2024, wherein various Sanitation Equipments were tendered;

Whereas, the technical bid was opened on 27-05-2025 and as per system generated report, it was found that M/s Dynaclean Industries participated in the above mentioned NIT as manufacturer through a authorized bidder namely M/s New India Enterprises;

Whereas, during the scrutiny of documents, a complaint has been received on 15-07-2025, wherein the allegations are made against M/s Dynaclean Industries as well as against bidder for submitting the false / forged Average Annual Turnover & Balance sheets. The complainant has also provided various documents as a proof to authenticate its allegations;

Whereas, the documents submitted with the complaint alongwith the technical bid were re-evaluated by the members of Technical Evaluation Sub-Committee and the following observations were made:

- i) UDIN no. 23508467BGVGJS5500, submitted for Average Annual Turnover & Balance sheets for the financial years ice 2021-22, 2022-23 & 2023-24 in the technical bid for M/s Dynaclean Industries was verified online and it was observed that the said UDIN was generated for the financial years 2019-20, 2020-21 & 2021-22 on 05.01.2023. The said UDIN was revoked by the concerned CA (Sanjeev Rastogi & associates, Membership No:508467) for mismatch in figures on 13.01.2023. Moreover, bidder has submitted same UDIN for Average Annual Turnover & Balance sheets for the financial years i.e 2021-22, 2022-23 & 2023-24, which is incorrect, as UDIN is a unique document and no different documents can have the same UDIN.
- ii) A document was also submitted by M/s JK Best Solutions, Jammu regarding the Average Annual Turnover of last three financial years of M/s Dynaclean Industries with UDIN No 25548836BMLZDN4354 generated by CA on 7.06.2025

(Jyoti Aggarwal & associates, Membership No: 548836) which was valid when verified online. As per the documents submitted, Average Annual Turnover of M/s Dynaclean Industries is Rs. 2.240 Cr & Rs. 6.77 Cr for 2022-23 & 2023-24, respectively contrary to figures submitted with technical bid.

- iii) Moreover, Balance sheets of the firm again asked in the minor infirmities by the Evaluation sub-committee were subsequently submitted by the bidder. Bidder has submitted balance sheets from two different CA for the same year with above mentioned UDIN (23508467BGVGJS5500 & 25548836BMLZDN4354) with incomplete data which is not corroborating with the average annual turnover submitted with technical bid.
- iv) A self-declaration document was submitted duly signed by Director of M/s Dynaclean Industries, wherein the manufacturer was unable to provide turnover of 2021-22 as the company was incorporated in 2022 only whereas the turnover of the said year was submitted in the technical bid. But the authenticity of the document cannot be ascertained.

Whereas, there are clear evidences of submission of false, inconsistent and possibly forged financial documents by the M/s Dynaclean Industries, which amounts to misrepresentation in the technical bid and violation of tender Terms & Conditions;

Whereas, the matter was placed before the Disciplinary Committee in its meeting held on 01-08-2025 and it was decided by the Committee that keeping in view the Principle of Natural Justice a show cause notice be served upon the manufacturer to explain the position within 07 days as to why JKMSCL shall not initiate action under rules as prescribed in NIT / SPP of JKMSCL;

Whereas, a Show Cause Notice was issued against M/s Dynaclean Industries vide No. JKMSCL/GM/DISC/2025-26/4982-89 dated 21-08-2025 for seeking explanation on the above mentioned facts but despite of lapse of considerable period the manufacturer did not submitted the reply;

Whereas, the matter was again placed before the Disciplinary Committee in its meeting held on 11-09-2025 and the Committee took note of the non-responsive attitude of M/s Dynaclean Industries in not responding to the Show Cause Notice, which depicts that the manufacturer has nothing to say in its defense;

Whereas, the Committee also found that M/s Dynaclean Industries had furnished false declaration / undertaking / information / forged documents and keeping in view the Terms & Conditions of the NIT/SPP, it has been decided by the Committee to blacklist the importer viz. M/s Dynaclean Industries for a period of two (02) Years;

Therefore, in view of above mentioned facts, M/s Dynaclean Industries, Coimbatore, Tamil Nadu is hereby blacklisted for a period of 02 Years from the date of issuance of this order.


