Terms and Conditions:


- 1. Delivery Site :** Rate are FOR Drug warehouse of JKMSCL/any Govt. Institution of J&K State, wherever installation is required.
- 2. Validity :** The rate contract shall remain valid for a period of two years from the date of issuance of the Contract which may be extended for a period of 90 days or till such time the new rate contract is finalized, whichever is earlier, with mutual consent of JKMSCL and successful bidder.
- 3. Taxes:** As mentioned above and as applicable.
- 4. Warranty:** Five Years from the date of installation.
- 5. Performance Security** You are further required to deposit the performance security equivalent to 5% of the total invoice value in the shape of Bank Guarantee in favour of FA/CAO, JKMSCL within seven days from the date of issuance of Purchase Order(s) from time to time.
- 6. Supplies** Within 90 days from the date of issuance of supply order.
- 7. Penalty** In case of extension in the delivery period with liquidated damages, recovery of liquidated damages shall be made at the rate of 0.25% per day for every day of delay subject to maximum of 10%.
- 8. Installation:** Installation / commissioning and necessary training for upkeep of the equipment shall be provided free of cost.
- 9. Availability of Spares:** Firm shall certify that the parts of the equipment shall remain available at least for a period of **five years** after the year of expiry of warranty period of five years.
- 10.** You have to certify that the rates mentioned above as quoted by your firm are the lowest rates applicable to all Govt./private Institution/PSU etc. Variation found if any, during the rate contract period by the Corporation/Intending department or any other agency shall be the sole responsibility of the Contractor/Supplier/manufacturer/importer.
- 11.** The supplier/manufacturer/importer shall ensure to supply the Brand new and unused item(s) strictly as per specifications/sample(s) approved. Variations found, if any, in instant case/or in later stages by the Corporation/Intending department/any other agency which may lead to sub standard or Not of standard/approved quality, shall be the sole responsibility of the supplier/ manufacturer/ importer/contractor.
- 12.** JKMSCL is at liberty to get the feedback from the end-user department/intending department regarding the functioning of the machinery & equipment supplied by your agency. Adverse report, if any, may lead to strict action against you under rules/terms & conditions of the NIT/guidelines issued by the Govt. from time to time.
- 13. Fall Clause:** The prices under contract shall be subject to price fall clause. The prices charged for the goods supplies under the contract by successful bidder shall in no event exceed the lowest price at which the

successful bidder sells the goods or offers to sell the goods of identical description to any other person(s)/Organization(s) including procurement agencies or any other department of Central Govt. or State Govt. as the case may be during the period till the performance of the contract. If at any time, during the period of the contract, the bidder reduces the sales price chargeable under the contract, he shall forth with notify such reduction to the JKMSCL, J&K and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale shall stand reduced correspondingly. It imply that if the contract holder quotes/ reduces its price to render similar goods at a price lower than the contract price to anyone in the Central/State Govt. at any time during the currency of contract including extension period, the contract price shall be automatically be reduced with effect from the date of reducing or quoting lower price for all delivery of subject matter of procurement under contract and the contract shall be amended accordingly.

14. **Risk Purchase** : If the bidder is unable to complete the supply within the specified or extended period, the corporation shall be entitled to purchase the goods or any part thereof from elsewhere without notice to the bidder on his (i.e., bidders) account at his cost and risk, with the prior approval of Managing Director JKMSCL, J&K. The bidder shall be liable to pay any loss or damage which the purchasing officer may sustain by reasons of such failure on the part of the bidder.
The bidder shall not be entitled to any gain on such purchases made against default. The recovery of such loss or damage shall be made from any sums accruing to the bidder under this or any other contract with the corporation/government. If recovery is not possible from the bill and the bidder fails to pay the loss or damage within one month of the demand, the recovery of such amount or sum due from the bidder shall be made from the bidder. In case supplier fails to deliver ordered goods, the risk purchases may be made at market rate from any other firm. It is mandatory for the approved supplier to acknowledge receipt of orders within seven days from the date of dispatch of order, failing which the procuring entity will be at liberty to initiate action to purchase the items on risk purchase provision at the expiry of the prescribed supply period.
15. **Orders shall only be placed on the basis of actual requirement and funds as available under the relevant Head of Accounts.**
16. **Payment shall be released after successful installation and commissioning of the equipment duly verified by the intending department.**
17. **Approved technical specifications shall remain same as per NIT (Annexure I)**

All the terms and conditions of the NIT, Standard Procurement of Procedure (SPP) of JKMSCL & LOI shall be part of this Rate Contract.

Fully Automatic Immunoassay Analyzer**Specifications of Fully Automatic Immunoassay Analyzer
(Chemiluminescence Basis)**

- Fully automated Random Access Immunoassay system, System should be USFDA and EU/CE certification.
- Sample type: Serum, Plasma
- Should have throughout of minimum 80 tests/hr.
- Should have continuous loading of both samples and reagents.
- Assay timing should not exceed more than 60 min for all Immunoassay parameters.
- Should have facility for minimum 50 samples position and separate STAT Lane for emergency samples.
- Should have capacity to load minimum 15 reagents packs of different parameters at a time. It should have automated inventory management system and bar codes scanner for reading reagents barcodes.
- All the Immuno assays should use disposable tips to avoid carry over and cross contamination to have reliable patient results.
- System should have facility to test routine and special Immunoassay Parameters.
- It should be user friendly operator in interface, touch screen monitor, keyboard, external PC with automatic data backup external printer to be provided.
- It should have facility to view and print Levy-Jennings charts; it should have facility to adapt Westgard rules.
- Interface must be complaint to LIS/HIS of the hospital and the bidder shall bear the cost of quoted instruments and backups with the HIS. The firm may submit other functional capabilities of the middleware such as provision of connecting with other laboratory analyzers future needs.
- Power supply 200200 V 50/60HZ. Online indigenous UPS with a minimum of 30 minutes backup for the main system for Uninterrupted power supply Capacity according to the requirement of autoanalyzer to work on the input of 180- 260 volts. Maintenance of al UPS and its parts, including batteries, for the tenure will be the responsibility of the company supplying auto analyzers.
- L1 should be decided based on CPRT (Cost per Reportable Test, All the consumables should be including in CPRT). Vender should quote the prices of Reagents including calibrator, controls, washing solutions, spare parts, lamps and all the accessory required to operate instrument or required to run the test AMC & CMC for instrument.
- Installation shall be performed by the supplies at his own cost. Furnishing of the rooms with computer tables-1, computer chairs-1, height adjustable laboratory chairs-1. All the materials should be of good quality and should last for 10 years. The vendor should be responsible to generate the document far the installation qualifications, operational qualification, and performance qualification at their own cost.
- Comprehensive training for lab staff and support services till familiarity with the system.
- One large size refrigerator of minimum 1000 liters for storage of kits/ reagents should be provided by the vendor at their own cost along with their maintenance.

- One No 2-ton split AC with stabilizers and installation for the maintenance of room temperature where equipment has to be installed.
- The company shall maintain the instrument and provide warranty for five years
- Warranty: 5 Years
- Vendor Should provide Backup Instrument of same/similar model as free of cost as and when required with same terms and conditions.
- If due to any lapse of the instrument, diagnostic kits, accessories, accessories reagents, calibrators and controls, the reports generated on a particular day are not of the required standard, the company shall be levied a penalty of Rs. 2000 per day.
