It is further clarified that:

1. For New Drugs Introduced in the market, Market standing certificate for three years is relaxed subject to furnishing of relevant documents against claims of new Drug.
2. The Products which were having patent rights and are now open to be manufactured by other manufacturers are exempted from submission of Market Standing Certificate for three years.
3. However, for both the above cases (1&2 supra), the bidders have to produce a certificate from the Licensing authority of the respective States that the products are being manufactured in their premises from the date of item declared as Off-Patent/ newly introduced in the market, as the case may be.
4. Wherever, Water for Injection/reconstitution has been asked with any drug/injection, it must be a composite Pack containing Drug and WFI/WFR. Particulars of WFI/WFR including name of manufacturer, batch no. date of manufacture, date of expiry etc. must be mentioned on secondary and tertiary packing. NABL report of the WFI/WFR must also be provided with the supplies.

Only technical/financial bids uploaded as per revised corrigendum shall be considered for evaluation.

All the bidders are requested to keep themselves updated and submit their e- bids through e-portal www.jktenders.gov.in as per specifications & BOQs. The amendments/ modifications shall be available on www.jktenders.gov.in, and www.jkmsclbusiness.com.

Rest all shall remain unchanged.
