Subject: Debarred/ Blacklisting order in favour of M/s Goldwin Medicare Ltd., 101/102 Valiankanni Tower, Mari Nagar Mumbai.

Order No: 84 - JKMSCL of 2024 Dated: 21 /09/2024

Whereas, this office had issued various purchase orders in favour of M/s Goldwin Medicare Ltd. for supplying the Dressing Materials and Surgical Disposables meant for Annual Demand 2019-20, Shri Amarnath Ji Yatra 2020, Annual Demand 2020-21, Annual Demand 2022-23 and Supplementary Demand 2022-23 against NIT No. JKMSCL/Dressing Materials/2019-21/313 dated 24/01/2019, JKMSCL/Surgical Disposable/2017/234 dated 11-04-2017 and JKMSCL/MED/2021/444 dated 11-01-2021 placed on 29-03-2019, 27-12-2019, 04-01-2020, 27-01-2020, 31-01-2020, 17-02-2020, 20-02-2020, 04-03-2020, 16-03-2020, 13-12-2021, 29-12-2021, 06-01-2022, 17-10-2022 and 17-03-2023;

Whereas, the above mentioned firm failed to execute all the purchase orders for the in question item(s) in light of the terms and Conditions NIT, Agreement and Rate Contract.

Whereas, the relevant Clauses of Policy for Blacklisting / Debarring of Product or Company is reproduced as under;-

- Clause 2: On account of failure to enter into agreement or withdrawal after agreement or refusal / failure to supply:
 - 2.1. The successful tenderer fails to execute the agreement after being declared as L-1, L-2 or L-3 etc. to perform the obligations under the tender conditions, EMD of such tenderer firm shall be forfeited and firm shall be liable for blacklisting for a period of not less than 2 years or the period specified in tender document.
 - 2.2. The successful tenderer after entering into an agreement withdraw or fail to honour commitments as per tender conditions, Security Deposit of such tenderer firm will be forfeited and firm will be liable for blacklisting for a period of not Less than 2 years.

Clause 3.4: If the supplier fails to execute atleast 60% of the quantity of item mentioned in purchase order and such failure in supply continues for three purchase orders, then supplier firm will be liable for blacklisting for a period of not Less than 2 years. As a result such supplier will be ineligible to participate in any of the tenders for particular item(s) of drugs / medicines for a period of not less than 2 years or the period specified in tender document.

Whereas, 03 non-execution notices were issued to said firm to explain position with regard to the non-execution the supply vide No. JKMSCL/GM/

P&S/2022-23/411-15 dated 20-05-2022, JKMSCL/GM/P&S/2022-23/4481-85 dated 21-07-2022 and JKMSCL/GM/P&S/2022-23/4603-06 dated 22-07-2022.

Whereas, firm failed to execute 65 purchase orders for the relevant item(s) in light of the terms and Conditions NIT and Rate Contract;

Whereas, the items approved in favour of the said firm were "Essential" which has put the patient healthcare at risk due to non-execution of supply of various items, which hampered the patient Healthcare in all the Health Institutions of Union territory of Jammu & Kashmir;

Whereas, a final non-execution notice vide no. JKMSCL/GM/P&S/2023-24/2236-42 dated 23-05-2023 was issued to the firm with the directions to execute the supplies at an earliest, failing which JKMSCL shall be constrained to initiate action as per NIT/SPP of JKMSCL;

Whereas, a Show Cause Notice was served to the firm vide no. JKMSCL/GM/P&S/2023-24/9743-48 dated 01-09-2023 with the directions to execute the supplies within 10 days, failing which JKMSCL shall be constrained to initiate disciplinary action warranted under rules including debarring the firm as per NIT / SPP of JKMSCL;

Whereas, despite of given various opportunities and lapse of considerable time, the firm has not executed the supplies till date;

Whereas, the instant matter was placed before the Disciplinary Committee of JKMSCL in its meeting held on 03-09-2024 for further examination and wherein it has been decided that action be initiated against the firm as per the clause 2 & 3.4 of the Policy for Blacklisting / Debarring of Product or Company of JKMSCL.

Therefore in view of the above facts, it is hereby ordered M/s Goldwin Medicare Ltd., 101/102 Valiankanni Tower, Mari Nagar Mumbai is hereby blacklisted/debarred from JKMSCL for a period of 02 years from the date of issuance of this order and the EMD(s) submitted by the firm against the above mentioned NIT(s) is/are hereby forfeited, in light of clause 2 & 3.4 of the policy for blacklisting /debarring of product or Company and Terms & conditions of the NIT/Rate Contracts.
