Subject: Debarred/Blacklisting order in favour of M/s Infutech Healthcare Ltd.

ORDER: - 38 -JKMSCL of 2024 DATED: - 21 -06-2024

Whereas, this office had issued various purchase orders in favour of M/s Infutech Healthcare Ltd for supplying the Drugs meant for Annual Demand 2022-2023, Free Drug Policy 2022-2023, Supplementary Demand 2022-23 through M/s Hussain brothers against NIT No. JKMSCL/Allop.Medicines/2020/402 dated 23-06-2020, as per the details mentioned below:

Whereas, the said firm failed to execute all the above purchase orders in light of the terms and conditions of NIT and Rate Contract;

Whereas, Clause 3.4 of the Policy for Blacklisting / Debarring of Product or Company is reproduced as under: -

If the supplier fails to execute atleast 60% of the quantity of item mentioned in purchase order and such failure in supply continues for three purchase orders, then supplier firm will be liable for blacklisting for a period of not Less than 2 years. As a result such supplier will be ineligible to participate in any of the tenders for particular item(s) of drugs / medicines for a period of not less than 2 years or the period specified in tender document.

Whereas, 04 non-execution notices were issued to said firm to explain the position with regard to the non-execution the supply vide No. JKMSCL/DGM/P&S/2022/333-36 dated 19-05-2022, No. JKMSCL/GM/P&S/2022-2023/4651-54 dated 22-07-2022, No. JKMSCL/GM/ P&S/2022/6882-87 dated 20-09-2022 and No. JKMSCL / GM / P&S / 2022-23/7399-7403 dated 08-10-2022;

Whereas, M/S Infutech Healthcare Ltd. failed to respond to any of the notices mentioned above nor executed the supply orders;

Whereas, vide this office No. JKMSCL/GM(P&S)/SCN/8020-25 dated 25-10-2022, a Show Cause Notice for non-executing the supply order as well as for being non-responsiveness to the communications issued by JKMSCL was served to M/s Infutech Healthcare Ltd. with the direction to explain the position failing which JKMSCL shall be constrained to initiate action as per NIT/SPP of JKMSCL;

Whereas, vide this office letter No. JKMSCL/GM/P&S/2023-24/2243-49 dated 23-05-2023, another non-execution notice was issued to M/S Infutech Healthcare Ltd.;

Whereas, despite of issuance of various non-execution notices and Show Cause Notices, M/s Infutech Healthcare Ltd. neither responded to JKMSCL nor executed the supplies;

Whereas, the drugs approved in favour of the said firm were "Essential Drugs" and non-execution of the said essential drugs hampered the patient care in all the Health Institutions of Union Territory of Jammu & Kashmir;

Whereas, the instant matter was placed before the Disciplinary Committee of JKMSCL held on 21-05-2024 for further examination and it was decided that a final showcase notice be issued against M/S Infutech Healthcare Ltd. keeping in view the principles of Natural Justice for seeking explanation as to why JKMSCL shall not initiate the process of blacklisting as per the Terms

& Conditions of the NIT / SPP and clause 3.4 of the Policy for Blacklisting / Debarring of Product or Company of JKMSCL.

Whereas, vide No. JKMSCL/MD/PS/2024-25/1723-25 Dated: 07-06-2024, a final show cause notice was accordingly served to M/s Infutech Healthcare Ltd for explaining its position in the matter.

Whereas, despite lapse of considerable time this office has not received the reply to the final show cause notice from M/s Infutech Health Care Ltd.

Whereas, the instant matter was again placed before the Disciplinary Committee of JKMSCL in its meeting held on 20-06-2024 for further examination and it was decided as under: -

"The issue was discussed in the disciplinary committee meeting on 20-06-2024 and it was found that various opportunities were given to M/s Infutech Healthcare Ltd. but the firm has failed to execute the supplies as per purchase orders and has not responded to the various Notices issued by JKMSCL."

Whereas, in view of above decision, it has been decided to initiate action against M/ Infutech Healthcare Ltd. as per the clause 3.4 of the policy for Blacklisting/Debarring of Product or Company by JKMSCL.

Therefore, in view of the above facts, it is hereby ordered that M/s Infutech Healthcare Ltd Shree Ganesh Chamber, A.B Road, Navilakha Crossing, Indore-452001(MP)-India is hereby blacklisted/debarred from JKMSCL for a period of 02 years from the date of issuance of order, in light of clause 3.4 of the policy for blacklisting/debarring of product or Company and Terms & Conditions of the NIT/Rate Contract(s).
