**Whereas;** e-bid for the finalization of Rate for the procurement of "Allopathic Medicines" was uploaded vide NIT reference No: JKMSCL/Allopathic Medicine/2021/447 Dated 14-01-2021, wherein amongst others, M/s.3 V Shoppe had also offered its bid against aforesaid NIT reference.

**Whereas;** M/S. 3V Shoppe had executed the supply of Iron and Folic Acid Syrup I.P 50 ml bottle Drug Code (1030A) Manufactured by M/S Zenith Drugs Pvt. to JKMSCL.

**Whereas;** following eleven Batches of Iron And Folic Acid Syp. I.P 50ml bottle, Drug Code (1030A) have been **declared as 'Not of Standard Quality' (NSQ) by empanelled labs of JKMSCL** Manufactured by M/s Zenith Drugs Pvt. Ltd. (Bidder) M/s 3v Shoppe, New Delhi :-

### As per clause of Quality Control Manual 5.3

"Immediately on receipt of NSQ report, the second sample should be sent to another empanelled lab/Govt. Lab by the QC Cell of JKMSCL.

The 05 batches of Iron and Folic Acid Syp. I.P 50ml bottle were resent to empanelled labs for confirmation and all the 05 batches were again declared as "NSQ"

**Whereas;** matter was placed before the Disciplinary Committee meeting held on 2<sup>nd</sup> December, 2022 at Corporate Head Office, Jammu and it was unanimously decided in the meeting to issue a Show Cause Notice to M/s. 3 V Shoppe as per principles of natural justice.

### Policy for Blacklisting / Debarring of Product or Company

#### As per clause 4.6

" If three batches of a particular item supplied under a tender tenure by the supplier are declared as Not of Standard Quality during its entire shelf life by an empanelled lab or Govt. Lab in test for assay and / or in any other parameter(s) and if such failures are further confirmed by another empanelled lab or Govt. Lab during its entire shelf life, the particular item of the drug shall be liable for blacklisting for a period of not Less than 2 years."

**Whereas;** a Show Cause Notice (SCN) was served upon to M/S. 3 V Shoppe vide this office letter No: JKMSCL/GM(Adm)/SCN/2022/8301-06 dated: 10-01-2023 wherein the firm was directed to explain the position **by or before 14-01-2023 upto 2:00 PM positively** with regard to supply of Iron and Folic Acid Syrup I.P 50 ml bottle Drug Code (1030A) Manufactured by M/s Zenith Drugs Pvt. Ltd to JKMSCL.

**Whereas;** no reply has been received from M/s. 3 V Shoppe in respect of the aforesaid Show Cause Notice till date.

**In view of the aforementioned facts, it is hereby ordered that Iron and Folic Acid Syrup I.P.50 ml bottle Manufactured by M/s Zenith Drug (P) Ltd supplied by M/s. 3 V Shoppe is hereby debarred/blacklisted from JKMSCL for a period of 02 (Two Years) from the date of issuance of this order with immediate effect.**
