Whereas; e-bid for the finalization of rate for the procurement of "Allopathic Medicines" was uploaded vide NIT reference No. JKMSCL/Med/2019/361 dated 19-09-2019 wherein amongst others M/S Vikrant Life Sciences firm also offered its bid against aforesaid NIT reference.

Whereas; M/s. Vikrant Life Sciences (P) Ltd, Delhi had executed the supply of Inj. Heparin Sodium 5000 IU/5ml Drug Code (373) Manufactured by M/S Celon Laboratories PVT. Ltd. to JKMSCL wherein four (4) batches were declared as 'Not of Standard Quality' (NSQ) by NIB, Noida.

Whereas; the details of four batches of Inj. Heparin Sodium 5000 Iu/5ml Drug Code (373), declared as 'Not of Standard Quality' (NSQ) by NIB, Noida Manufactured by M/s Celon Laboratories Pvt. Ltd. Supplied by M/s Vikrant Life Sciences (P) Ltd are as:-

Whereas; matter was placed before the Disciplinary Committee meeting held on 2nd December, 2022 at Corporate Head Office, Jammu and after due deliberation it was unanimously decided in the meeting to issue a Show Cause Notice to M/s. Vikrant Life Sciences (P) Ltd, Delhi as per principles of natural justice.

Policy for Blacklisting / Debarring of Product or Company

As per clause 4.6

"If three batches of a particular item supplied under a tender tenure by the supplier are declared as Not of Standard Quality during its entire shelf life by an empanelled lab or Govt. Lab in test for assay and / or in any other parameter(s) and if such failures are further confirmed by another empanelled lab or Govt. Lab during its entire shelf life, the particular item of the drug shall be liable for blacklisting for a period of not Less than 2 years"

As per clause 5.8.

"Further, if the sample has been tested by the Govt. Lab at any stage, its report will be conclusive & final unless challenged as per provisions of Drugs & Cosmetics Act, 1940.

Whereas; a Show Cause Notice (SCN) was served upon to M/s.Vikrant Life Sciences vide this office letter No: JKMSCL/GM(Adm)/SCN/2022/8307-12 dated: 10-01-2023 wherein the firm was directed to explain the position **by or before 14-01-2023 upto 2:00 PM positively** with regard to declaration of Inj. Heparin Sodium 5000 Iu/5ml Drug Code (373) Manufactured by M/s Celon Laboratories Pvt. Ltd. supplied by M/s.Vikrant Life Sciences to JKMSCL as "Not of Standard Quality"

Whereas; reply submitted by M/s. Vikrant Life Sciences (P) Ltd, Delhi vide their letter No: VLS/JKMSCL/H/2022-23/003 Dated: 11-01-2023 is not satisfactory to the facts elaborated above.

In view of aforementioned facts, it is hereby ordered that Inj. Heparin Sodium 5000 Iu/5ml Manufactured by M/s Celon Laboratories Pvt. Ltd. supplied by M/s.Vikrant Life Sciences (p) Lt, Delhi is hereby debarred/blacklisted from JKMSCL for a period of 02 (Two Years) from the date of issuance of this order with immediate effect.
