2. As per tender notification Pre-Bid meeting was held on scheduled date i.e. 20-11-

2024 at Corporate Office Jammu and Srinagar.

3. Corrigendums were issued vide this office No: JKMSCL/Dental Material/Corg/638/2024/9453-56 dated 23-12-2024 and JKMSCL/Dental Material/Corg/638/2024/9558-61 dated 27-12-2024.

4. Accordingly, e-bid was opened on 15-01-2025 at 11.00 a.m., in the presence of Technical Evaluation Committee constituted by Boards of Directors during 1st Board Meeting and amended by Boards of Directors during 3rd Board Meeting, JKMSCL for the purpose, and as per the system generated report following 07 bidders have participated in the said NIT. (placed as Annexure A).

After the opening of e-bids, the Technical Evaluation Committee decided that the compilation, preliminary scrutiny and evaluation of bid documents shall be carried

scrutiny and recommendations in the matter. After downloading the minor infirmities submitted by the bidders, the same shall be re-evaluated by the Sub Committee constituted for the purpose and the final report shall be placed before Technical Advisory/ Evaluation Committee for further the recommendation.

- Accordingly, the subcommittee after evaluation of the bid documents of bidders submitted the report of the shortcomings /Clarifications to be asked from concerned bidder on dated 11-03-2025 and the concerned bidders were asked to submit their minor infirmities by or office vide 2.00 28.03.2025 up to JKMSCL/GM(K)/2025/MI/638/917-21 dated 18-03-2025
- The subcommittee after evaluation of the documents of bidders as minor 9. infirmities/clarifications submitted the status report with respect to minor infirmities on dated 25-04-2025 with the remarks that few important documents were not submitted by most of the concerned bidders/manufacturers/importers.
- 10. Accordingly, the matter was placed before the Technical Evaluation/Advisory vide 29-04-2025 its meeting called on Committee in JKMSCL/GM/Adm/2025/776-88 dated 28-04-2028 and after threadbare discussion the committee decided "Since the items in question are of pivotal importance in the patient care and in the interest of healthy competition one time chance of seven(07) days be given to all the bidders across the board and resubmit the minor infirmities" the minutes of which were circulated vide this office No: JKMSCL/Dental Material/638/2025/796-802 dated 29-4-2025.
- 11. As such the minor infirmities notice was issued vide this office No: JKMSCL/GM/K/MI/638/2025/812-816 dated 01-05-2025 to the all the 07 bidders mentioned above for submission of the pending documents as minor infirmities by of before 08-05-2025.
- 12. After evaluation of the submitted minor infirmities of all the 07 bidders the subcommittee submitted its final report on dated 20-05-2025 for further necessary action in this regard thereby by qualifying technically following bidders for further necessary action.

Letters were issued to the companies for submission of the samples and to the experts for sample evaluation at Sample Warehouse Gangyal, Jammu with extension in submission of last date of submission of samples as 21-06-2025.
