**Subject: Blacklisting /Debarring order in respect of M/s Sam Kem, 15-B & 10-B, A.K.V.N. Industrial Area, Rangwasa Rao, Indore (M.P.).**

**ORDER NO: 08-JKMSCL of 2026**

Whereas, JKMSCL vide Order No. 66-JKMSCL of 2025 dated 21-08-2025 blacklisted/debarred M/s Sam Kem, 15-B & 10-B, A.K.V.N. Industrial Area, Rangwasa Rao, Indore (M.P.) for a period of two (02) years on account of concealment of material facts regarding blacklisting/debarring of its product by other procuring entities and submission of false undertaking/affidavit at the time of participation in the tender;

Whereas, aggrieved of the aforesaid order, the firm filed WP(C) No. 2358/2025 titled M/s Sam Kem Vs UT of J&K & Ors. before the Hon'ble High Court of Jammu & Kashmir and Ladakh at Jammu;

Whereas, the Hon'ble High Court vide order dated 27-01-2026 granted liberty to the petitioner-firm to submit a detailed representation before JKMSCL and further vide order dated 16-02-2026 directed the respondents to consider the representation before the next date of hearing;

Whereas, pursuant to the directions of the Hon'ble Court, the representation submitted by M/s Sam Kem was examined and the matter was placed before the Disciplinary Committee in its meeting held on 27-03-2026 for reconsideration; and

Whereas, the Committee examined the representation of the firm, the records available on file, the earlier proceedings conducted by JKMSCL and all connected documents in the matter;

Whereas, after due deliberations, the Committee recommended that the blacklisting order imposed upon the firm may be revoked, however, the debarment/blacklisting in respect of the product involved in the case, namely **Liquid Paraffin IP 100 ml**, shall continue in view of the facts and circumstances already established on record;

Now, therefore, in view of the above and on the recommendations of the Disciplinary Committee, it is hereby ordered as under:

- i. Order No. 66-JKMSCL of 2025 dated 21-08-2025 issued by JKMSCL blacklisting/ debarring M/s Sam Kem, Indore (M.P.) for a period of two years is hereby revoked.
- ii. However, blacklisting/debarring shall continue in respect of the product Liquid Paraffin IP 100 ml supplied/authorized by M/s Sam Kem, Indore (M.P.) for a period of two (02) years from the date of issuance of Order No. 66-JKMSCL of 2025 dated 21-08-2025.
- iii. The forfeiture of EMD(s), pursuant to Order No. 66-JKMSCL of 2025 dated 21-08-2025, shall remain unaffected.
