Subject: Supply of Vancomycin & Methylprednisolone with the same batch in the same packing- initiation of administrative action thereof.

ORDER

Whereas, the orders for the supply of Inj. Vancomycin 500 mg were placed with M/S Sanyog Enterprises Private Limited, Sanyog House, B-1 Yadav Park, Delhi vide this office Purchase Orders dated: 14th March, 2016, 15th February, 2016 & 24th December, 2016, for Drug Ware House, Government Medical College, Srinagar against the Annual Rate Contract approved by J&K Medical Supplies Corporation Limited (JKMSCL) in his favour.

Whereas, against the aforesaid purchase orders, it was brought to the notice of this office that M/S Sanyog Enterprises Private Limited, Sanyog House, B-1 Yadav Park, Delhi has supplied Inj. Vancomycin 500 mg & Inj. Methylprednisolone Sodium Succinate for injection USP with the same batch in the same packing at Drug Ware House, Government Medical College, Srinagar & the same has further been delivered at GB Pant Hospital Srinagar for use.

Whereas, it was also brought to the records that the samples of Inj. Vancomycin 500 mg had been lifted from G.B Pant Hospital Srinagar by the Controller, Drug & Food Control Organization, J&K on the request of Principal/Dean, Government Medical College, Srinagar. Accordingly, vide this office No. PS/MD/JKMSCL/2016/6503-09, dated 13th December, 2016, the Controller, Drug & Food Control Organization, J&K was requested to lift the samples from Drug Ware Houses, Government Medical College, Srinagar & supplies be confiscated, if required, under Drug & Cosmetic Act 1940.

Whereas, as per the reports submitted by General Manager-Kashmir, JKMSCL vide No. JKMSCL/PS/GM/K/846-48, dated 31st December, 2016, the Controller, Drug & Food Control Organization, J&K has seized the samples of both the medicines i.e. Inj. Vancomycin 500 mg & Inj. Methylprednisolone Sodium Succinate for Injection USP, which were found with the same batch and in same packing & both the drugs taken are as shown in the form 17-A and Form 15, and

further the team of officers from Drug Ware House, Srinagar has seized all the remaining 8,400 vials of the said drug.

Whereas, on the basis of report received & preliminary inquiry made thereof, M/S Sanyog Enterprises Private Limited, Sanyog House, B-1 Yadav Park, Delhi was asked to explain its position in the matter vide this office No. JKMSCL/MD/PS/2016/ 6535-42, dated 2.01.2017, within three (03) days positively from the date of issuance of letter.

Whereas, the reminder to submit the reply within stipulated period was issued vide this office letter No. JKMSCL/Adm/Enquiry/18/2016, dated 04.01.2017.

Whereas reply to the said letter has been received from M/S Sanyog Enterprises Private Limited, Sanyog House, B-1 Yadav Park, Delhi on 4th January, 2017, which on perusal was found un-satisfactory, as the same was contradictory to the preliminary inquiry report.

Whereas, as per the photographs received on mail indicating that the products in question have been manufactured by M/S Alliance Biotech, Baddi, Solan (HP) for M/S Concept Pharmaceutical Pvt. Limited A-28/3, MIDC, Chikalthana, Aurangabad-431006 clearly depicts that that two wrappers have been printed with the name of two different salts i.e. Inj. Vancomycin 500 mg & Inj. Methylprednisolone Sodium Succinate for Injection USP with the same batch number ADG-088, and said wrappers have been pasted on the same size vials, which clearly marks a question on "GOOD MANUFACTURING PRACTICES" and distribution system adopted by the respective firms M/S Alliance Biotech Pvt. Limited , M/S Concept Pharmaceutical Limited & M/S Sanyog Enterprises Pvt. Limited.

Whereas, the administrative inquiry has also been ordered vide Order No. 68 of 2016, dated 02.01.017, besides other actions to be taken under law/Standard Procurement Procedure (SPP)/NIT.

In light of preliminary inquiry and facts of cases placed on file, the undersigned, after thorough scrutiny has taken the following decisions to be implemented with immediate effect:

- I. That the registration of M/S Sanyog Enterprises Private Limited, Sanyog House, B-1 Yadav Park, Delhi with JKMSCL is hereby suspended with immediate effect, till the out-come of inquiry/finalization of the case.
- II. That M/S Allied Biotech Pvt. Limited & M/S Concept Pharmaceuticals Pvt. Limited *are hereby debarred to participate in any of JKMSCL tender(s) till further orders, subject to the out-come of inquiry/finalization of case.*



Separate orders in the matter shall accordingly be issued as per the out-come of inquiry/finalization of case.
