MINUTES OF MEETING

Sub: Minutes of Meeting of the Technical Evaluation/ Advisory Committee held on 15.06.2026 for the finalization of Rate Contract for the "Hiring of Vehicle Services for JKMSCL (2026-28)" under NIT No. NIT/JKMSCL/Vehicle Services/2026-28/687 dated 06.04.2026.

1. E- bid for the finalization of **Rate Contract for the "Hiring of Vehicle Services for JKMSCL (2026-28)"** uploaded vide no. **NIT/JKMSCL/Vehicle Services/2026-28/687 dated 06.04.2026** and is opened on 2nd May 2026 at JKMSCL Corporate Office, Jammu and Srinagar at 12.30 P.M.
2. The aforesaid tender was opened in the presence of technical advisory/evaluation committee constituted for the purpose and as per the system generated report the following bidders participated.
 - i) M/s City King Travels, Jammu
 - ii) M/s Aarav Travels, Jammu
 - iii) M/s Romesh Motors, Jammu
 - iv) M/s Iqbal Motors, Kashmir
3. With reference to clause 2.1.9 Chapter II of the Standard Procurement Procedure, it was decided by the Technical Advisory/ Evaluation Committee that the Chairman, Technical Advisory/Evaluation Committee shall get the preliminary evaluation done by the sub-committee and then shall get the minor infirmities asked from the respective bidders, if any by giving them 3 days maximum to submit/ upload the infirmities.
4. Accordingly, the bid documents were scrutinized by the Sub-Committee and minor infirmities were communicated to the concerned bidders through the notice issued vide No. JKMSCL/GM/J/2026-27/162-167 dated 22-05-2026.
5. The minor infirmities / shortfall documents submitted by the bidders were examined and re-evaluated by the Sub-Committee and the report submitted is re-produced as under:




